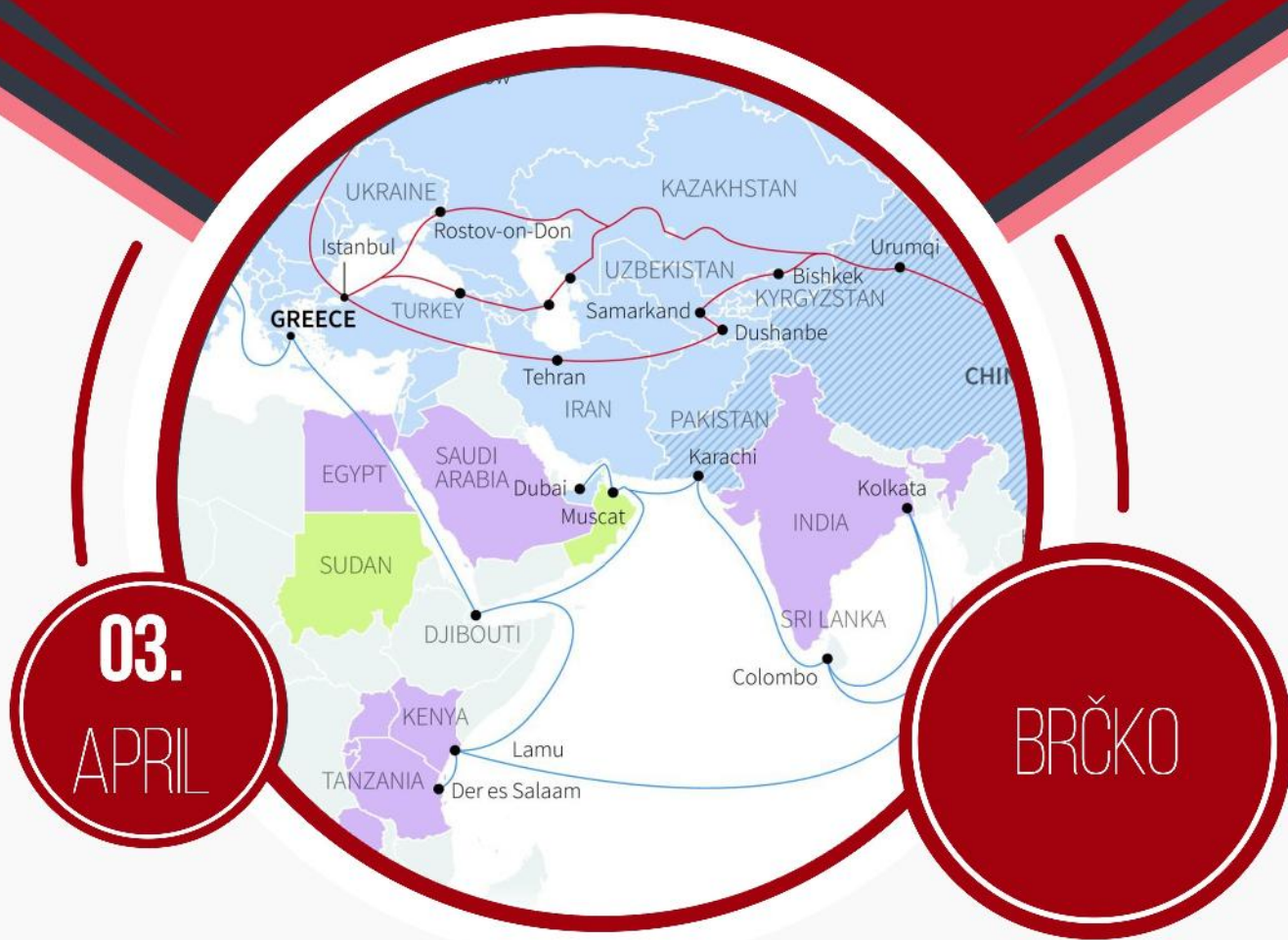

TECHNICAL INSTRUCTIONS TO THE AUTHORS

Total length of the paper: up to 15 pages. The title of the paper should be written in capital letters (Times New Roman 14 Bold). Subtitles should be written in small capitals (Times New Roman 12 Bold). Line spacing in the text should be 1 (Times New Roman 12). The abstract/summary with keywords should be included and translated into English. If the article is written by several authors with different affiliations, it is necessary to indicate the affiliation for each of them (it is possible to indicate more than one institution for one author) in the footnote. Not more than three co-authors may participate in one article. Bibliography – cited literature includes bibliographic sources, such as articles, monographs etc. and should be given in a separate section of the article in the form of a list of references.

REGISTRATION
